#### **E. SUBMISSION OF DOCUMENTS:**

Philippine passport holders need to be valid at least six (6) months after the return date to the Philippines. All necessary documents for visas must be submitted 45 days before departure.

#### F. BAGGAGE ALLOWANCE

When joining a tour group, only one piece of suitcase is allowed for all to fit inside the baggage hold of the tourist bus. Baggage allowance is subject to airline rules and is subject to change without prior notice.

#### **G. ACCOMMODATIONS**

All accommodations will be on twin sharing basis in standard rooms containing two beds on 5 star class hotels. unless otherwise specified. Participants requiring one double bed should specify request at time of registration.

- If a single room is preferred, there will be an add-on cost of \$755.
- If suite or superior room is desired (rather than a standard room), please specify your request on your reservation form so we can check availability and add on price.
- If a single person traveling alone wishes to share a room with another person of the same gender, please indicate in the registration form that he/she is allowing the Organizers to assign a roommate to her/him when available. Otherwise he/she must be prepared to pay for Single Room charge. bed should request this specifically upon registration.

#### H. MEDICAL EMERGENCY

In a medical emergency, every effort will be made to address the concern through the Insurance concierge and reach the next of kin of the participant for medical expenses incurred outside of the insurance coverage. The participant agrees to not make claims from Highlight Tours for any medical emergency arising from any pre-existing conditions and from physical, mental, and emotional distress caused from touring with a group.

#### I. VIDEO AND PHOTO PERMISSION

Photos and videos of your image or likeness may and unconsciously be included in promotional, social media and published material of High Light Tours. Please advise, if this is unacceptable, so that appropriate editing may be done to exclude the participant from these media publications.

#### J. TRAVEL CLEARANCES, FORMS, and PERMITS

#### J.1 NON-PHILIPPINE PASSPORT HOLDER

Participants holding foreign passports may require an emigration clearance certificate (ECC) upon exit the Philippines. Participant shall notify High Light Tours immediately to apply for clearance needed prior the tour departure. A clearance certificate applied by the participant on its own shall furnish High Light Tours a copy at least 2 weeks prior departure.

#### J.2 PHILIPPINE GOVERNMENT EMPLOYEES

Government employees who are still in active service are required to secure travel order/clearance from their respective offices. An approved leave form is also required. Participants shall provide Highlight Tours a scanned or photocopy of their clearance and forms at least 2 weeks prior departure for documentation/filing purposes. Forms and clearances shall be always carried during travel.

#### **K. TOUR BRIEFING**

Tour Briefing will be done shortly before departure to provide additional information about the schedule, flights, clothing and security, or any other questions participants may have. This is also the time that visas, tickets and travel kits will be distributed.

#### L. LAND ARRANGEMENT

HighLight Tours can assist participants NOT originating from MANILA with the group for flight arrangements. Contact Ms Julie Bernardo at High Light Tours office for information.

Accommodations and airport transfers for those not traveling with the main group may be arranged at an additional cost. To make these arrangements, please contact Ms Julie Bernardo at High Light Tours.

#### M. TRAVEL TAX AND AIRLINE FUEL SURCHARGE

Airline tax, fuel surcharge and Travel Tax are charged to all Philippine Passport holders whenever they leave the country on a commercial flight. These may not be refundable if you cancel your flight. You may be exempt from the Travel Tax if you are holding a non-Philippine passport and your status in the Philippines is temporary.

#### N. CANCELLATION PROCEDURES & CHARGES

- 1. High Light Tours and the tour operator reserve the right to forfeit the deposits when a participant voluntarily cancels his booking. The deposit amount may be assigned to someone else with charges.
- 2. After deposits and payments are made, cancellation charges are applied according to the following time frame:

More than 90 days before departure = \$500 admin fee 89-61 days prior to departure = 20% cancellation fee 60-45 days prior to departure =35% cancellation fee 44-30 days prior to departure =50% cancellation fee 29-15 days prior to departure = 75% cancellation fee 14-8 days prior to departure =90% cancellation fee 7 days to Day of departure= 100% cancellation fee

- 3. Please accomplish your cancellation request in writing with accompanying documentation (such as medical certificates) stating reason for cancellation and submit to HIGH LIGHT TOURS Office on or before departure date.
- 4. High Light Tours reserves the right to cancel the group if they fall below the minimum number of participants based on the price pegged. It may be agreed that an additional amount may be applied for a smaller group

#### O. FACILITIES

Certain facilities such as museums and sightseeing tours may not be available as stated. Alternatives will be offered whenever possible.

#### P. PACE AND ACTIVITY

This tour requires that every participant is physical fit and able to walk without assistance. Adults over the age 70 pay extra for medical assistance and insurance coverage and may be required to submit a medical clearance. High Light Tours reserves the right to refuse further service and send home unruly participants at their own expense. If they not comply, Highlight may be compelled to request the assistance of authorities and may be blacklisted by the host country

#### Q. DATA PRIVACY & CONFIDENTIALITY

As provided by the Philippine Data Privacy Act (RA10173), all personal information that includes the Name, Birthdate, Address, Passport and similar data of participants are kept in confidentiality and will be used only for travel processing purposes such as visa, entry permits and boarding requirements. These are kept for the required duration of the tour and for refund and audit purposes. After which, these are deleted from our servers. No third party entities are allowed to access private information about the participants except if they themselves request it or with their permission.

#### R. INSURANCE, CLAIMS & ADJUSTMENTS

Participants must immediately contact any High Light representative should any problem arise in order for them to intervene and resolve the problem before it potentially escalates or aggravates itself.

#### S. NOSHOW/UNUSED SERVICE/REFUNDS

No refunds will be granted for any unused services, un-availed meals and ungranted requests that would otherwise been free and/or already included in the package price. Unused services due to tardiness that resulted in missing the tour bus which ultimately missing the whole or part of the itinerary or similar situations.

#### T. INABILITY OF HOST TO JOIN TOUR

In the event that the host pastor is unable to join the tour for whatever reason, a replacement pastor will be provided by the organizers to host in his/her behalf. This will be decided on within a prescribed period of time. The organizers agree that they will share the burden of responsibility for the costs of cancellation charges resulting from participants' backing out because of this reason.
